Why **Code Rule 59** Matters: Under 12 N.Y. Comp. Codes R. & Regs. Section 59 ("**Code Rule 59**"), if a New York employer has a high experience modification rating for purposes of workers' compensation insurance, the **New York Compensation Insurance Rating Board** will issue a notification to that employer referred to as a **Code Rule 59** notice that requires the employer to perform a mandatory safety consultation using a New York Department of Labor certified consultant. An employer may receive a **Code Rule 59** notice if it has over **\$800,000** in payroll and an experience modification rating over **1.20**.

A **Code Rule 59** notice requires employers to engage a certified consultant to conduct an audit focused on workplace safety practices. The goal is to establish a strong safety foundation that protects employees' well being and supports a safer work environment. While this process can feel overwhelming for organizations balancing daily operations, a proactive, expert-guided **Code Rule 59** consultation helps ensure compliance reduces the risk of **injuries**, and can contribute to **lowering workers' compensation insurance costs** by improving safety performance and experience modification ratings.
